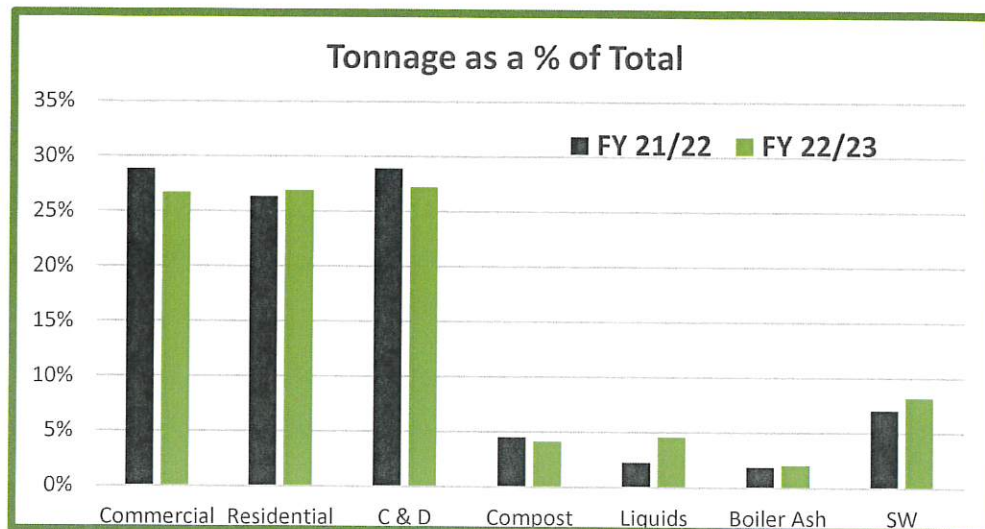

SUBJECT: January 2023 Financial Statements

For the month ending January 31, 2023, Metro Waste Authority is showing a YTD net income of \$10,113,344 versus a budget of \$1,970,612. YTD operating revenues are 15% over budget while YTD operating expenses are 6% under budget.
